



QISSLUN GUIDE FOR BEGINNERS

What is MUN?

1. Model United Nations is an educational role-playing game.
2. Each delegate represents a country in a UN committee to discuss an important global issue.
3. First, you write a Draft of Resolutions.
4. Through debates and revisions, students aim to construct the best resolution for each conference topic.
5. Resolutions are then voted in the committee. A resolution needs a majority to be passed.
6. The QISSLUN has SEVEN main bodies: General Assembly, Security Council, Economic and Social Council, Chinese Committee, Youth Conference, Human Rights Council, and Special Committee.

MUN outline:

Day 1 :

- a) Opening event in the theatre (where organizational information is shared.)
- b) Chairs give speeches and take role calls.
- c) Chairs will announce the topics of the conference
- d) Divide into cooperation groups and get acquainted with the group chairs.
- e) Writing resolution for the next day.

Days 2 and 3 :

- a) Finalize resolution
- b) debates are held, and a joint resolution is drawn up.

Preparatory work:

1. Learn the Basics About Your Country:

- a) Land – Find your country on a map. Check out your size, terrain and neighbors.
- b) Politics – Check if you're a democracy, a pseudo-democracy or an authoritarian power. If a democracy, check with the party that is in power.
- c) Data – Population size, main languages, demographic breakdown and wealth, usually by looking at the Gross Domestic Product (GDP).
- d) News – Glance at the news and see what your country has been up to most recently.

2. Go to QISSLUN Website and learn about your committee; this information can help you understand where the chairs want the debate to go:

- a) read the general introduction
- b) read the chair report

3. Select a topic from your committee. You will research and write a draft resolution about it in the future.

4. Research your country's position on the topic:

- a) look at the news to get an idea of what policies your country would implement.
- b) Broaden your search terms, don't always Google your country + topic:
 - i. Most countries don't publish their information in English
 - ii. Politicians don't like to make committing statements
 - iii. Your country has no direct relation to the topic

Opening speech:

1. Write an opening speech(Mandatory in QISSLUN):

- a) Usually 60 seconds.
- b) Give a general impression of your country's view of the topic
- c) Point out some ideas to solve the problems in line with your country's interests.
- d) Include facts and practical policies

- Preambulatory clauses should provide the audience with a brief overview of the background and context for the proposed actions
- Operative clauses should describe the actions to solve the problem
- Use formal, 3rd person, and diplomatic language
- The entire resolution should be ONE long sentence
- Check for spelling or grammar errors
